8:02 Starting a State/Provincial/Regional Association

As Written:

MEMBERSHIP:

The membership of the Association shall be made up of members of the Red Knights International who live within the boundaries of the State/Provincial/Region in question. Members must be in good standing with their Chapter and/or the International. Red Knight members who live outside the state may become an Association member but shall not have a vote or hold an elected office. Chapter membership in the Association is not mandatory. Inclusion to or exclusion from the Association shall be by vote of each chapter's membership. The Association shall accept any Chapter at a later date that votes to be part of the Association.

As Proposed:

MEMBERSHIP:

The membership of the Association shall be made up of members of the Red Knights International who live within the boundaries of the State/Provincial/Region in question. Members must be in good standing with their Home Chapter and for the International. Red Knight members who live outside the state of their home chapter may become an Association member but shall not have a vote or hold an elected office and be eligible to vote and/or hold an elected office in the state of their home chapter. Chapter membership in the Association is not mandatory. Inclusion to or exclusion from the Association shall be by vote of each chapter's membership. The Association shall accept any Chapter at a later date that votes to be part of the Association.

Rationale:

Members whose home chapter is within a State/Provincial/Region Association should have the rights as a member eligible to vote and be elected to hold an Association office as long as their home chapter is a member of the Association.

Therefore: In accordance with By-Law 3:25, it is hereby moved that the Board brings charges against the individual member.





All Chartered Chapters must be established by the International Executive Board in accordance with all the provisions of the International Constitution, By-Laws and Rules & Regulations. Each Chartered Chapter shall adopt the By-Laws and the Constitution of the International for the administration of its business or for the purpose of the incorporation of their chapter in their governmental area, may develop Chapter By-laws that are consistent with the International Constitution and By-Laws.

A Chartered Chapter, so established, may exercise full power and authority of a Chapter business SOG (Standard Operating Guideline) to the extent that the transaction of Chapter business SOG is consistent with the International By-Laws. Chapter Government is responsible for the organization of Corporate activities at the Chapter level, including the collection of International dues from Chapter members and overseeing Chapter membership and compliance of the International Corporation. Any proposed Chapter of a State, Province or Country applying to become a Chartered Chapter of the Club will be designated under a State, Province or Country identification with the next consecutive number or number selected and approved by the International Executive Board. 

Rationale:

Nominations Chair Tom Caisse

As brought to the attention of the International Executive Board on 10/16/2023 by Nomination Chair Tom Caisse. "I am writing to the International Board of Directors to inform them of a point of order that should have been called at the ABM as respects the International Constitution and By-Laws change to section 3:05 Vacancy."

"The untended consequence would then be the board operating for 90 days without one of it's members and the extra cost and confusion of running potentially non-concurrent electronic elections with multiple ballots. Non-concurrency and confusion were the points of the current 180-day period wording of the original section 3:05 Vacancy which underwent several reviews by the IBOD before it was presented to the membership in the package of By-law changes that were necessary to transition to electronic voting.

if the intent is to expedite the process of filling what would become an open position when the incumbent is sworn into their position, then a lot more wording needs to be considered and the cost and confusion factor also taken into consideration.

As written, the Nominating Committee is putting the IBOD on notice that they cannot execute on the current Section 3:05 Vacancy and would suggest this be addressed prior to the situation arising.


I went back through the Nominating Committee history and found that this has only happened once since electronic voting was implemented in 2011. In 2014 we had a resignation at the ABM in PEI but the change suggested would not have impacted that." *Tom Caisse Nominations Chair 10/16/2023*

"The bylaws committee has worked on the discrepancy and agrees with the International Board and that the 3.05 must be reviewed once more. It is the Bylaws Committees opinion that a reverting to the last revision would be in the best interests of the organization." *Rasmus Lillemose By-Laws Chair* 2/26/2024

International Board of Directors:

The International Board of Directors has reviewed the "Point of Order" and by majority vote concurs with Nomination Chair Tom Caisse and By-law Chair Rasmus Lillemose. The Board feels that reverting to the last revision would be in the best interests of the organization. While we do understand and recognize the good intent that was intended by this revision, without further consideration of the effects caused, this cannot be enforced.



BY-LAW SECTION 2:11 ANNUAL MEETING

(As written)

The Club's Annual Convention will be held on third (3rd) week of August. Any request to change this date shall be submitted to the International Board 36 months prior to the year of the convention in question. The International Board will review and discuss the request and reply back after the date of the next scheduled Executive meeting at which the request will be discussed.

The Annual Meeting of the International Executive Board (The Annual Corporation Meeting) shall be held at the convention site as designated by the International Executive Board for hearing and action upon the reports of elected officers and transacting such other business as has properly come before the International Executive Board. The place and time of such meeting may, however, be fixed by consent of a majority of the International Executive Board. The Annual Convention locations shall be accepted up to five (5) years in advance. Chapters or Associations shall present their intentions to host a convention at the Club's Annual Meeting. Delegates at this meeting shall vote for the location in question. The successful bidder may withdraw their request up to three (3) years prior to the awarded convention date, after which they are required to honor their request to host the convention in the year they have requested.




