"The signs are to raise awareness for people to look for motorcycles in the area," said David Die, safety officer and road captain for the Texas Chapter.

"We want the signs (Motorcycle Safety "Share the Road" signs) posted where traffic counts are high with motorcycles or by establishments that bikers attend," Die said. More than half of motorcycle accidents occur because the driver did not see the bike coming," Die said in a recent interview with the Orange Leader newspaper.

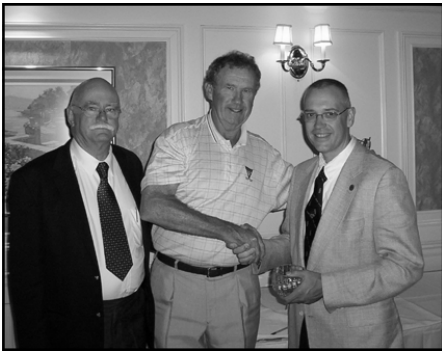

Maryland Fallen Firefighters Memorial Parade and Dedication

On June 11, 2006, the long awaited dedication of the Maryland Fallen Firefighters Memorial was held in Annapolis, Maryland. Over 1,500 uniformed fire personnel were in attendance along with apparatus from each Department that had a Line of Duty Death since 1840.

The Chairman and founder of the Maryland Fire and Rescue Memorial committee, Chief Don Mooney (Lansdowne VFD) thanked all those who worked over the past ten+ years to achieve this milestone; honoring our fallen brothers and sisters. The Memorial is an open plaza consisting of memorial bricks and two walls with the names of the LODDs. The main focus is the bronze sculptures of a male firefighter and a female EMT, both send a message of love and service as they turn to wave goodbye to sculptures of an older man, a woman, and a boy for the last time at that split second as they paid the ultimate sacrifice.

The Dedication was preceded by a parade through parts of Annapolis. The parade of apparatus was led by sixty members of the Red Knights representing all 5 Maryland Chapters and PA 11.

After the dinner Americade founder Bill Dutcher made an appearance to talk to the Red Knights in the dining room to thank us for the club's participation and helping to make each year's Americade a special event.

Wednesday evening was also the Americade Fashion Show. A block of Red Knights, with an RKMC banner in tow, waited in the crowd for one of the fashion show participants, who happened to be a Red Knight. Once on the runway, the Red Knights banner went high in the air and the cheers, hoots, and hollers began. The crowd and the fashion show's MC all enjoyed the Red Knights' enthusiasm. And the others modeling that night made mention that the Red Knight in the show got the most cheers!

Thursday night saw a great spread hosted by New York 12 at the Red Knight Open House at the Lake George FD. Over 200 RK members and friends signed the guest book and shared camaraderie throughout the late afternoon and evening. A number of chapters also set up shop making their RKMC wares available for all the members.

Even with the damp, cool, and windy weather on Saturday over 75 Red Knights made it out to participate in the Americade Parade. A legion of bikes with riders adorned with fire helmets rolled down Canada Street. International President Ed Brouillet led the parade with a formation of HD firefighter specials adorned with flags as

they escorted our membership and the remainder of the Americade parade down Canada Street and to the top of Prospect Mountain. It was a great time.

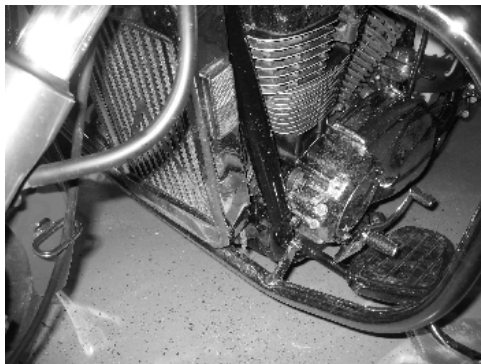

Red Knight of the Year Award

It is the goal of the Red Knights International Motorcycle Club to identify and honor a member each year as the Red Knight of the Year. This award will be known as the "**Perry Carter Award**", in remembrance of Perry for his endless work and dedication to the Red Knights Motorcycle Club.

Only an active member in good standing with the International and their Chapter may be eligible for this award. This includes Members at Large.

Each Chapter may nominate a member from its Chapter for the Red Knight of the Year. The nomination should be sent to the State/ Province Representative and then to the Regional Director. Each Regional Director would then forward their nominee to the Eastern Regional Director who will serve as the Chairperson for this award. A Member at Large, Chapter President, or an Executive Board member of the Red Knights International Motorcycle Club may nominate any Member at Large for the award. This nomination would follow the same path as listed above.

The committee will consist of the Eastern Regional Director, as Chairperson, the past two recipients and the four Regional Directors.

Members who are nominated should have been present at 50 % of the Red Knights Motorcycle Club chapter events during the year. The member nominated should have visited at least one other Chapter during the year. The member nominated should have attended the International Convention in the past. The Member nominated should represent and signify the Red Knight's standard in their dealings with the public and the International's members.

The Regional Director shall forward a letter with their nomination outlining the member's qualities shown for this award to the International President. The deadline for receiving the nomination shall be prior to March 1st of each year. The final decision will be made at the Spring Board meeting each year.

All members of this committee will be notified of the names and information that have been submitted to receive this award. They are to review those names and information on why they were nominated and submit their choice in order of first, second and third to the Committee Chairperson, no later that 14 days before the spring International Board Meeting.

The winner of this award shall receive recognition and their fee for the Annual Conference of the year they are receiving the award. The Red Knights International Motorcycle Club should pay for the registration to the annual Convention.

Duties of the International Officers:

PRESIDENT: Over sees total operation

VICE-PRESIDENT: 2nd in Command, Director for Overseas chapters and the MAL program

SECRETARY: Oversight of Insurance for chapter/association/region events and the Insurance data base and related wavier record keeping (7 years). Advertising; Updating & maintaining SOG's manual, Chapter By-Laws and Association By-Laws file; Chapter, Association, and Regional Applications and Charters and State/Province Representative Roster; Maintains rosters of International Committees and Deceased Members; Responsible for Board Meeting agendas and minutes, E-Mail motions/voting/record keeping, Keeper/shipper of Banners/Flags, and oversees By-Laws Committee. Responsible for the International's Equipment Inventory data base. Publishes Chapter President's Letter (twice a year), Sending of cards/flowers for death of member, and is the contact person for chapters/members questions.

TREASURER: Maintains the Master Member Roster, President List, MAL roster, Chapter Approvals and numbers, and Chapter Start dates & Location. Responsible for Collection of Dues for Chapters/MALs and Pass Due reminders. Responsible for financial dealings including Accounts Payable, Accounts Receivable, Filing of all tax forms with IRS, Working with Attorneys on Incorporation, Corporation Annual Report, and IRS Annual Report. Maintains EIN data base for Chapters and EIN filing with IRS. Monitors Expenses of the Club.

REGIONAL DIRECTOR: Works with states to set up Associations; works with State Representatives and local chapters as needed and to keep chapters updated, handling concerns of the members, chapters and regions. Works with Secretary on new chapter applications promoting membership in states without chapters and promoting Regional Associations.

QUARTERMASTER: Responsible for Trademark agreements with chapters/associations/regions. Purchasing and Maintaining of RKMC merchandise, selling of merchandise to members and chapters and designs & maintains merchandise order forms. Submits Quartermaster Financial Records. Research new sources of merchandise and new merchandise including requests for regalia from non-members. Oversees the FORK program. Special Projects assigned to the Quartermaster include -Motorcycle raffle, ticket/flyer design/distribution/finance, -Business card design/production/distribution, -Executive Board Uniforms, -Resolution of E-Bay infringement problems, -Resolution of internet infringement of trademark, -Resolution of chapter to chapter sales problems, -Proving art work to chapters/vendors/individuals and maintaining its integrity, -Banner design/purchase, -Flag purchase, -RKMC flag redesign, -Research suppliers/materials for 2007 patch & pin, -Dixie Confederation patch design/purchase/distribution, -Formatting of By-Laws chairman's laptop.

First, I want to thank everyone for re-electing me as your vice-president this past summer. My congratulations also to Secretary Bill Snodgrass, South East Regional Director Gene Downs, Western Regional Director Graham Clark and Quartermaster Lynn Komandt on their re-election at the most recent RKMC Convention. I am looking forward to continuing to work with the members and all those serving on the International Board again this year.

I continue to be busy with personal contacts in my efforts to provide service to the Members-at-Large and other members of our club. Since our last convention I have answered and/or read 361 emails; sent 15 applications to prospective firefighters who want to become Red Knight Members-At-Large, and signed up 9 new members (one of which lives in Germany). I have spoken with another new member who now wants to start a chapter in Pennsylvania and as your VP I continually answer inquiries from members concerning our policies on a variety of issues.

As your Vice-president I have had the honor this year to represent the International on two separate occasions for September 11th memorials. On September 10th I attended a parade in Tampa, Florida where attendance was limited to 3,000 riders. Over 2,000 additional bikers were turned away. I also attended a parade on September 11 in Daytona that was hosted by Florida Chapter 10. There were over 200 bikes at this rally with several Florida Red Knights Chapters represented. The host chapter expected between 60-100 bikers – and the number that showed was a great surprise!

On October 12th I had the solemn responsibility to represent the Red Knights International at a funeral for a firefighter who was a Fire and Iron member. Firefighter Jenkins was coming home from the station when he was struck from behind while waiting for a red light. He was dragged over 100 feet. I was proud to say there were over 1,500 firefighters and units from 50 cities in attendance.

On October 13th I attended the Florida Firefighter Memorial at the Florida Firefighter College in Ocala to honor those who gave their lives in the line of duty between October 2005 and October 2006. There were 4 names added to the memorial this year.

As a member of the International Board I continue to work with the other board members in promotion and leadership of the RKMC. The weekend of November 11 the Executive Board met in Syracuse, NY where we spent over 9 hours working on the Constitution and By-Laws, new SOG's, the Trade Mark Agreement, and other challenges that face our organization. Your Board takes their role as stewards of the organization very seriously and we all strive to provide a solid foundation for where our great club can continue to grow.

As your VP I must also advise our Members-At-Large and Non-U.S. Chapters (excluding Canada) that it is time to renew their membership. Our Treasurer has reminded us of the importance in getting our dues to him in a timely manner. So let's try and get those dues in before December 31st this year.

Again, I thank everyone for support in my bid for re-election. I'm looking forward to working for you again in the New Year. I hope you have a great Christmas and a Happy New Year.

Thanks to all our members and friends in New York City for another great convention!

Each of the members attending the convention had many opportunities to tour this great city, either on formal tours arranged by our hosts, or on their own. One such self-guided tour was while the International Board was holding their meeting. Several of the executive's wives went into the city by subway with their trusty guide, Daniel Waldspurger our MAL from Switzerland. They tell us that New York is an "interesting" place, especially the subway. Their time on their own included entertainment by the world's worst accordion player and a horse and buggy tour of Central Park. This group concluded their day's trek with lunch in a little Bistro and a visit to the Trump Towers. That is just one example of the great time that our members enjoyed in New York!

Friday was a great day with an awesome bus tour of New York. The Red Knights went to beautiful Cathedrals, had a walking tour of Central park, had lunch and shopping in Little Italy and had an incredible tour guide who gave you lots of history of the city.

Back to the hotel in the late afternoon, it was time to head to the Cookout at Killarney's Bar. It was a real social event, but it was cut short by darkening skies. Some people did not make it back to the hotel dry! Have you ever sat at a stop sign when it was raining that hard with no rain gear?

Saturday morning brought the usual general meeting. Some information presented at the meeting included:

- There were 34 chapters present.

- The club is now advertising the Red Knights in 20 states.
- Although near bankruptcy in 1994, through careful management of funds and an increased growth, the club is very solvent with a treasury of \$115,639.88.
- Since the organization is growing so quickly, within the next few years the International will be looking into having a paid business manager. Both the Secretary and the Treasurer put in an incredible amount of voluntary time and it is getting to be too much.
- All officers running for re-election were voted in for another term of service. Reports were given for all the committees and from all the representatives for future conventions.

Next year is hosted by Massachusetts Chapters, with the primary host being Mass-1— since that is where it all began! 2008 is in Sandusky, Ohio (Home of the park with the best roller coasters), 2009 is in Florida, 2010 in Louisiana, and 2011 in Ocean City, Maryland.

After a 3-hour meeting, we were off on a

motorcycle ride to ground zero, a very sobering place. While there we visited the Fire Station across the street, thought back and spoke of the worst day in our country's history and had a moment of silence for those who lost their lives that day.

Saturday evening brought good food, good friends and great music. A special guest was there to present a gift to the New York Fireriders. They had taken the Ride to the Wall this spring and had met a Marine who gave them a tour of the Pentagon. The Marine was so impressed to meet the group from New York who were at the Trade Towers during the event, that he came to present them with a gold sword for their bravery and dedication.

The Perry Carter Award presented to Mark Kerr from Connecticut-2 for being an exemplary Red Knight. He was very touched by the honor of the award.

The 50/50 raffle brought in approx. \$1400 and was won by Lynn Komandt, the International Quartermaster. She donated her share of the winnings to the Memorial Fund. Plans for the memorial in Boylston, Mass are to have it dedicated at the 2007 convention.

As usual the Sunday morning Adios Breakfast was a bittersweet event. We remember the great week that we had, but have to say goodbye to friends that we may not see for another year. A good time was had by all.



**Notification To all Chapters of the Withdrawal of The Red Knights
Group Letter of Determination Application**

On June 13, 2006 I received a reply to our application for a group letter of determination to the Internal Revenue Service. In the letter there were outlined several areas of the application that the I.R.S. wanted more information in greater detail than what had been provided.

I contacted the I.R.S. by telephone and talked with the caseworker that had been assigned to our application. After several minutes of discussion it became very apparent that International would not be able to provide the IRS with the information and detailing of such that they wanted to proceed with the application.

They then gave me a list of items that they wanted fully documented, listed are several of them.

*Provide a list of the parent and subordinate organizations, which conduct activities in Canada or other foreign lands.

*Provide a detailed description of the types of activities conducted by a typical subordinate. Include concrete examples of specific activities conducted, rather than stating the goals they hope to achieve. You must show the commingling, fellowship, recreation and socializing there is among the subordinates.

* Provide documentation verifying the EIN of the following subordinates and they list 10 Chapters that they want the original letters that issued their EIN's.

* Complete form 1024, which is a statement of Revenue and expenses along with a bank balance sheet for a typical subordinate.

*Submit a signed affirmation that the parent and subordinates will not conduct charitable gaming, issue tax-exempt bonds, or use professional fundraisers or telemarketers for fundraising purposes.

*Will the subordinates be filing a group return and if so you must apply for a separate EIN for the group return. We had never ever considered a group return.

*If your subordinate organizations are corporations, submit a complete copy of their Articles of incorporation and any amendments thereto that show evidence that they have filed with and been approved by the state in which they are incorporated. About ten of the chapters on the application are incorporated and I don't know if the chapters that are incorporated have kept things up to date by filing their annual reports or not. (I can't even get them to pay their dues on time least of all give me all this other information).

*Provide a listing of all parent organization board members and all subordinate organizational board members. On the original application they again told me just to list the Chapter member that would be the contact person with the IRS in regards to the EIN, which in most cases is either the chapter president or the treasurer.

Which is what I gave them along with the listing for our International Board.

The list of other requirements that they have demanded were way beyond the ability of the International to meet on the required intervals and timetable that they spelled out.

So on June 14th 2006 after consulting with the International Executive Board I withdrew our application. Now it reverts back to what has always been the requirement, that the responsibility of filing and reporting all tax related information with both the State and Federal levels is that of the individual chapters. It is further recommended to the chapters that they apply for a letter of determination on an individual bases for each of their chapters.

Greetings Brothers and Sisters,

I want to thank membership for electing me to another term as the International Secretary. As before, I will continue to work for the membership. The next year offers many new and exciting goals for our membership as we grow and work to take our club into the future.

The Red Knights International Firefighters Motorcycle Club is growing in membership and chapters. At this time we have 255 active chapters. And our membership is over 7100. We have added State Associations and the Regional Directors are working with the State/Province Representatives to set up the Associations. If your state or province needs more information on the formation of an Association, please contact your Regional Director.

Our insurance program has grown each year. In 2006 we provided insurance for 38 events for our chapters. This is an increase of 31.5% over 2005. I want to thank the chapters for requesting the insurance three weeks before their event and returning the waivers in a timely manner.

In dealing with new chapters, one question that I am asked a lot is "what do I get for my International dues?" First I would like to compare our dues with other clubs. The Red Knight yearly dues are \$7.00 per year. Harley Owners Group yearly dues are \$45.00. GWRRA yearly dues are \$45.00 per year. AMA yearly dues are \$39.00 per year. IAFF motorcycle club yearly dues are \$50.00. Blue Knights Motorcycle Club yearly dues are \$20.00 per year. Wind and Fire dues are \$20.00. As you can see our dues are the lowest of any International Motorcycle dues. For your \$7.00 you get the following;

- Banners that any chapter/association can use for a period of three weeks
- Matching dollar grants up to \$200.00 for promotions of chapters or associations
- Lunch at Americade and other national events
- Decals
- Newsletters twice a year (cost over \$6500.00 each mailing)
- Advertising Handouts for your chapters
- A Memorial Park in Massachusetts
- An International Convention (we assist with insurance and funding)
- Regional Convention (we assist with insurance and funding up to \$500.00)
- State Conventions (we assist with insurance and funding up to \$500.00)
- Help-A-Knight program
- Grand Tour (certificate and pin)
- Web Site
- Quartermaster Items

We are always looking and listening for other ways to improve the benefits for our membership.

Red Knights International Firefighters Motorcycle Club® Inc. Office of the Executive Treasurer **Reminder to all Chapter Presidents International Membership Dues**

Membership dues payable to the International run from January 1st till December 31st of each year.
A grace period for payment is granted from January 1st till March 31st.
After that date dues are subject to a \$50.00 late payment fee.

There are eight classifications of membership:

1. Charter Member – An active member that has joined a chapter within one year of the chapter being chartered. See Section 4:08
2. Active Member – Is available to anyone who has been a member of the fire service, See Section 4:04
3. Associate Member – A person who has never been in the fire service. See section 4:05
4. Social member – The spouse, boyfriend (1) Girlfriend (1) offspring's of an Active or Associate member or member-at-Large. See Section 4:06
5. Special Honorary Member – Granted to a person of a recognized religion for the position of chapter chaplain. See Section 4:07
6. Member-at-Large – Person's who qualify for Active membership but are too far removed from any established chapter to join. See Section 's 2:01 & 2:01A
7. Life membership – See Section 2:01
8. Compassionate Honorary Member – See Section 2:01 (8)

Dues for new members joining a chapter shall be \$8.00 per member in their first year of membership and will be prorated at the rate of 25% reduction in the third quarter and 50% reduction in the fourth quarter.

2007 Dues Rates:

- Active or Associate Member \$7.00 each
- Social or Honorary Member \$4.00 each
- Compassionate Honorary Member no charge
- New member any classification \$8.00

Dues for chapters are to be sent in U.S. funds to the International Treasurer: Please be sure to include a current membership roster which has the members Name, Address, Zip or postal code, Phone number including area code, and Email address if they have one. And lastly their membership status Active, Associate, Social, Honorary, Life or Compassionate Honorary.
